**WHEREAS**, the Town of Brighton 2013 Tentative Budget has been prepared and presented to the Town Board and filed with the Town Clerk as the Preliminary Budget; and

**WHEREAS**, public hearings on such Preliminary Budget were held at meetings of the Town Board on October 10, 2012 and October 24, 2012 at 7:30 p.m. prevailing local time, and all persons having an interest therein have been heard in the matter; and

**WHEREAS**, the Town Board approved and adopted the Preliminary Budget for the year 2013 as amended on October 24, 2012 as the 2013 budget; and

**WHEREAS**, the Supervisor, the Director of Finance, and the Budget Officer have recommended an amendment to the 2013 Budget as previously adopted as said budget relates to the amount to be raised in charges for the West Brighton Fire Protection District and have recommended a Two Hundred Thousand Dollar (\$200,000.00) reduction in said amount; and

**WHEREAS**, the Town Board desires to approve such Budget as amended; it is therefore

**RESOLVED**, that a memorandum, dated December 4, 2012, from William W. Moehle, Supervisor, Suzanne E. Zaso, Finance Director, and Andrew C. Robinson, Budget Officer, concerning a proposed amendment to the 2013 Budget relating to the West Brighton Fire Protection District, be received and filed; and be it further

**RESOLVED**, that the Town Budget for the year 2013, as amended to reduce the amount to be raised in charges for the West Brighton Fire Protection District by Two Hundred Thousand Dollars (\$200,000.00) to an amended total of \$740,175, from the Budget adopted on October 24, 2012, is hereby approved and adopted as the Town's Final Budget for 2013.

Subject: Proposed Amendment to the 2013 West Brighton Fire Protection District Budget

Based on updated information received since adoption of the 2013 Special District Budgets, we recommend the following amendment to the West Brighton Fire Protection District's 2013 adopted budget be approved by Your Honorable Body.

Decrease estimated revenues from special district assessment charges by \$200,000 (SF.FIRED.3415.1028) with a corresponding increase in appropriated fund balance.

This change would decrease the 2013 West Brighton Fire District Tax Rate by 21.27% from 2.269290 per \$1,000 of Assessed Value to 1.786552 per \$1,000 of Assessed Value.
