On March 31, 2017 the Brighton Police Department received a report of a pedestrian struck personal injury motor vehicle accident in the area of 2001 South Clinton Avenue. The striking vehicle had left the scene.

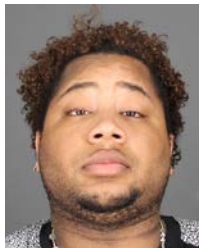
Officers had the area of the accident secure and were conducting an investigation into the incident.

Later that night Clark McDonald, age 90, approached an officer with his 2016 Nissan Rogue that had damage to the vehicle and stated that he was driving in the area early that night and thought that he may have hit something in the roadway. Officers took custody of the vehicle and brought McDonald to the Brighton Police Department.

As a result of a very thorough and comprehensive investigation by Brighton Police Department personnel, **Tommy B. Jackson**, age 28, the foster child of Clark McDonald has been identified as the driver of the vehicle that struck pedestrian Destiny Forbes, causing significant and life threatening injuries. Jackson left the scene and later provided a false written deposition regarding the accident.

On April 3, 2017 Tommy B. Jackson was charged with Leaving the Scene of a Personal Injury Accident (New York State Vehicle and Traffic Law section 600-2A; Class E Felony), Making a Punishable False Written Statement (New York State Penal Law section 210.45; Class A Misdemeanor) and Unlicensed Operation of a Vehicle (New York State Vehicle and Traffic Law section 509-1; Traffic Infraction).

Brighton Town Judge John Falk arraigned Jackson on the charges and set bail in the amount of \$2500.00.
