Honorable Members:

I would like to recommend that a budget transfer be approved from the following:

Parks Department Corbett's Glen Park Maintenance Supplies (A.DPW 7122 4.11) in the amount of \$2,800.

To the following:

Parks Department Buckland Park Maintenance Equipment (A.DPW 7115 2.40) in the amount of \$2,800.

The Parks Department currently needs to replace our 2004 Club Car Carryall 2 Utility Cart with electric dump bed. This cart is one of our most important pieces of equipment for our maintenance efforts within the parks and allows us to cover our vast park acreage for garbage pick-up, trail maintenance projects and various other tasks. The existing cart is 12 years old and has exceeded the useful life expectancy of 8 years. It is currently out of service with many issues that either cannot be repaired or would prove unreasonable to do so considering the age and condition of the unit. After much investigation I have discovered the following utility cart that can meet the current and future maintenance demands:

TORO GTX Gas Workman #07130 with 12v Electric Lift Bed: \$7,776.60 available through Grassland Equipment Corp as a NYS Bid item. Group 40625 Contract # PC66756

We currently have \$5,000 available in A.DPW 7115 2.40. This transfer from A.DPW 7122 4.11 would allow us to cover the difference needed to replace the existing utility cart while providing enough remaining funding to take care of the anticipated 2016 maintenance efforts at Corbett's Glen . The new cart will allow us to continue our maintenance efforts which will include the need to cover more trail distances with future trail construction projects such as the Brickyard Trail.



In the Park and Highway Department's 2016 budgets, funding is available for mowing and landscape services. These services are utilized for the mowing and maintenance of park properties as well as neighborhood parks and cul-de-sacs throughout the Town. The Town's procurement policy in regards to the bidding process was followed. Bid notices were mailed to several firms along with publishing of a public notice in the Brighton-Pittsford Post on March 10th.

Bids were opened on Thursday March 24, with Extreme Lawn Care & Landscape submitting the only proposal. Attached is an itemized price list. This company would be a new mowing contractor but they come highly recommended by the Town of Henrietta which currently contract services with them and their prices are lower or equal to the rates we received in 2013 from Woodgate Landscape who held the previous mowing contract.

I respectfully recommend that you award the 2016 mowing and landscape contract to Extreme Lawn Care & Landscape and authorize the Supervisor to execute a contract for these services. I would also note that the Town has the option to extend this agreement for two additional one-year terms.

Town staff reviewed the bids for completeness and accuracy and concluded that the lowest price quote provided by *Brasco International, Inc., 32400 Industrial Drive, Madison Heights, MI 48071* is representative of the costs necessary to supply the bus shelter and stormwater planter and the contractor is qualified to perform the proposed work. Therefore, I am requesting that FASC recommend that the Town Board award the project to the low, responsible and responsive contractor, *Brasco International, Inc.*, for a lump sum price not to exceeded \$43,500.00.

We are also requesting that the Supervisor be authorized to execute any necessary change orders that do not collectively exceed ten percent of the funds allocated for the GIGP bus shelter and stormwater planter project.

Dear Councilperson DiPonzio and Committee Members:

The Genesee Transportation Council authorized supplemental agreement #4 to the Highland Crossing Trail agreement. The supplemental agreement will fund the construction and construction inspection for the project and will increase the total project cost by \$1,674,000.00 of which \$1,331,200.00 is funded by a federal Transportation Enhancement Program, TEP, grant. The remaining balance \$342,800 represents the local match and will be reimbursed by the Town of Brighton and the City of Rochester. The construction bid documents will be developed to identify the cost of construction within the City and the cost of construction in the Town. The City and Town share distribution will be based on the costs identified in the bidding documents. Fisher associates prepared a probable cost of construction which suggests that the Town share will be 63% and the city share will be 37% or \$215,964 and \$126,836 respectively.

The NYSDOT administers the TEP funding and recently provided Supplemental No. 4 to the Federal-Aid Local Project Agreement for this project and requested that the Town endorse this agreement. This agreement will allow the NYSDOT to reimburse the Town of Brighton eighty percent of the construction and construction inspection phase fees for this project.

In addition, the NYSDOT requested that the Town approve a resolution which:

- 1. Identifies who is authorized to execute Agreements, certifications, and reimbursement requests on behalf of the Municipality/Sponsor
- Confirm that the Municipality/Sponsor understands and accepts the stipulations on the agreement including it's associated schedule, appendices, exhibits and attachments
- 3. Confirm that the Municipality/Sponsor has appropriated the funding necessary to deliver the project as described in Schedule A of the Agreement.

On September 10, 2007 the Honorable Town Board approved the use of \$3,213.00 worth of seized assets to purchase seven (7) EO Tech 552 Holographic rifle sighting optics (this purchase was made via the seized asset account A. POLCE 3125 2.17). On December 1, 2009 an additional three (3) EO Tech 552 Holographic rifle optics were purchased totaling \$1,283.52 (from account Police Equipment A. POLCE 3120 2.17). The total amount expended on the EO Tech sights was \$4,496.52.

It was recently learned that the EO Tech Holographic rifle sights were recalled due to performance issues. The manufacturer requested that we return the optics to them for full reimbursement. On March 11, 2016 the Brighton Police Department received a check in the amount of \$4,605.00.
