1. Approval of Minutes – Receive and file minutes of the April 30, 2019 meeting.
  
2. Purchase with Forfeited Property Fund /related budget modification (Police Dept.) – Request from Police Chief Mark Henderson for Town Board action to approve the purchase of audiovisual equipment in an amount not to exceed \$4,000 utilizing Forfeited Property Funds. Further approval to increase the budget account: A.POLCE.3125.2.14 (audiovisual equipment) by \$4,000 supported by the Forfeited Property account A.889.JSTCE. The equipment will be housed in one of the Town courtrooms and the Court will fund the cost of the installation of the equipment. (see letter from M. Henderson).
  
3. Amend budget in an amount not to exceed \$5,000 to allow for purchase of temporary speed humps (Highway Dept.) – Request from Mike Guyon for Town Board action to amend 2019 budget by appropriating an amount not to exceed \$5,000 to account D.HWY.5110.2.30 Highway Equipment utilizing the Highways Assigned Fund Balance account D.909. The exact amount to be appropriated will be available when the quotes for the purchase of two (2) portable speed humps are available. The Town’s procurement policy will be followed to make this purchase (see letter from M. Guyon).

**RE: PURCHASE USING SEIZED ASSETS ACCOUNT**

Dear Board Members:

The Brighton Police Department introduced Body Worn Cameras in 2016. A portion of this program is supported by the use of Seized Funds. Since the inception of the program, the use of digital evidence (video footage) has increased during criminal and traffic prosecutions.

The Brighton Town Courts currently have one courtroom that is equipped with audiovisual equipment capable of displaying video evidence. The Brighton Town Court applied for but did not receive, complete grant funding for adding audiovisual equipment to the second courtroom.

There is a provision in the Guide to Equitable Sharing for State, Local, and Tribal Law Enforcement Agencies that allows for the use of seized assets for Joint Law Enforcement/Public Safety Operations.

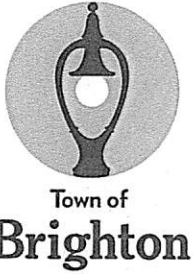
I am proposing that the Police Department purchase audiovisual equipment for the second Brighton Town Court courtroom. Installation costs will be borne by the Courts.

I propose that the Proceeds of Forfeited Property be used to fund this purchase. I request that appropriations in account **A.POLCE.3125 2.14 (audiovisual equipment)** be increased by an amount not to exceed **\$4,000.00**. The total expenditure will be supported by the use of Forfeited Property account **A.889.JSTCE**. I have consulted with the Department of Justice and they concur that the use of seized forfeiture asset funds for the purpose of this purchase is appropriate.

Re: Temporary Speed Humps

Dear Councilperson DiPonzio and Committee Members:

The Town of Brighton Department of Public Works is investigating the use of speed humps to reduce vehicle speeds along known cut through streets. Based on catalogue price quotes we anticipate that the cost of two 20-foot-wide temporary speed humps will not exceed \$5000.00. Staff will adhere to the Town's procurement policy to purchase the speed humps. Town staff will obtain three price quotes and select the lowest price quote for purchase. We are recommending that the FASC authorize the Town Board to purchase two speed humps at a cost not to exceed \$5000.00.

The purchase of the speed humps is not a budgeted item. Funding will be provided from the Highway Fund with funds being appropriated to account D.HWY.5110 2.30 from the Highway Fund Balance Account 909.
