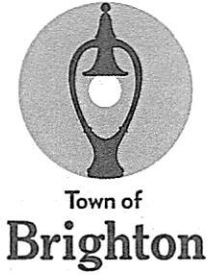

Re: Emergency Tree Removal
Transfer of Funds

Dear Councilperson DiPonzio and Committee Members:

In September of 2018 the Town awarded the tree maintenance and removal services contract to Birchcrest Tree and Landscape Inc. The Birchcrest Tree and Landscape Inc., tree removal unit prices are significantly higher than those in the Monroe County contract which were utilized to develop the 2019 tree maintenance and removal services budget during the Capital Improvement Plan process. Therefore, there is not sufficient funds in account A.DPW.8560 4.43 to perform emergency tree removals. We are requesting that FASC recommend that the Town Board authorize the transfer of \$10,000 from the contingency account A.UNDST.1990 4.90 to account A.DPW.8560 4.43 to fund emergency tree removal.
